The developed handbooks of innovative educational technologies were distributed among Uzbek partners, and in the process of their conduct, lecturers acquired skills to improve their teaching methods, and they recognize that this handbook was really fruitful and useful to them. The developed handbooks of innovative educational technologies were distributed to 100 lecturers/teachers from each Partner institutions from Uzbekistan (total at least 150) in both English and Russian languages.




HIEdTec QUESTIONNAIRE RESULTS

We received 140 answers to our questionnaire.


1. Which country are you from?

From 140 answers, 84.9% of the responders find the structure of the training, extremely well-structured, 11.5% as well structured and 3.6% normal











MODERNISATION OF HIGHER EDUCATION IN CENTRAL ASIA THROUGH NEW TECHNOLOGIES (HiEdTec)




10. Was the final documents produced and sent in an appropriate time?/10. Были ли окончательные документы подготовлены и отправлены в надлежащеевремя?
