Section 1.

#### MISSION OF THE CENTER, MAIN GOALS AND OBJECTIVES

Objectives:

**1.1** Adapting the educational system to the digital generation using active and effective ICT-based innovative educational technologies, thereby contributing to the digital transformation of education...

#### Section 2.
