INTRODUCTION

Cloud-based Virtual Library of Kyrgyzstan has been created with digital educational resources based on the distance learning environment Moodle LMS. The main server is located in KSTU. Address of the library is <u>www.openkstu.kg</u> Through the means of HiEdTec project, communication equipment was supplied to the universities of the consortium of Kyrgyzstan, on the basis of which a virtual library was created. The virtual library is developed in accordance with the requirements of the project, there are mandatory elements – the logo of the European Union, the logo of the HiEdTec project and information about the project.

Moreover, on the main page of our virtual library there are categories of courses. These are courses of the following universities: International University of Ala-Too (P5), K.Tynystanov Issyk-Kul State University (P6) and Kyrgyz State Technical University named after I. Razzakov (P7). In parallel, IKSU created its own resource - a virtual library, which address <u>www.moodleiksu.kg</u>





PROJECT OVERVIEW

The Cloud-based Virtual Library of the digital educational resources is designed to provide access to educational courses in the open space to all teachers, as well as students, thereby providing the opportunity for EVERYONE to study at ANY time and in ANY place with the help of ANY teacher, using ANY end device.

The main goal of the project is to adapt the education system in the partner countries to the digital generation by introducing and effectively using innovative educational technologies and didactic models (IET & DM) based on ICT in the educational process.

The consortium consists of 24 full partners - universities from 4 EU countries and 5 PCs. The project will help transform partner higher education institutions into innovative universities and improve the quality of trained specialists needed to carry out the digital transformation of industries (Industry 4.0).

The Project acknowledges the use of technology in transforming learning, developing collaboration solutions, enhancing the role of educators in innovative technology-supported learning environments allowing them to be engaged in professional learning experiences that will prepare to apply research-based approaches to didactic teaching.
















12. Was the installation of the cloud-based Virtual Library of the digital educational resources done on time?
