INTRODUCTION

The purpose of the Concept evaluation was to gather feedback of knowledge and experience of EU partner country Universities and Tajikistan partner Universities on developing Concepts of adapting the education system to the digital Generation considering the specific conditions of Tajikistan.

The aim of the concept is to adapt the education system to the digital generation by developing and effectively applying innovative educational technologies and didactic models in teaching, thereby providing the opportunity for **EVERYONE** to study at **ANY** time and in **ANY** place with the help of **ANY** teacher, using **ANY** end device a computer, laptop, tablet, phablet, smartphone, etc.

The concept was developed on the basis of:

PROJECT OVERVIEW

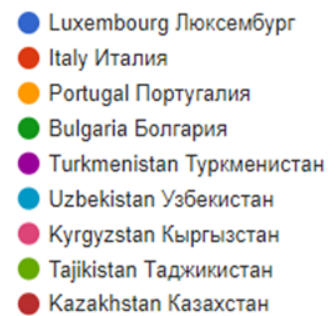
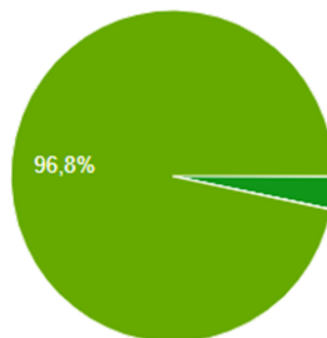

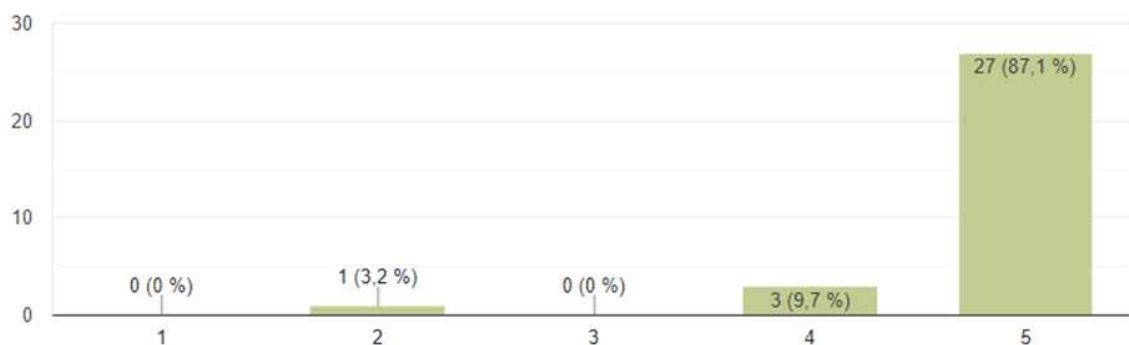

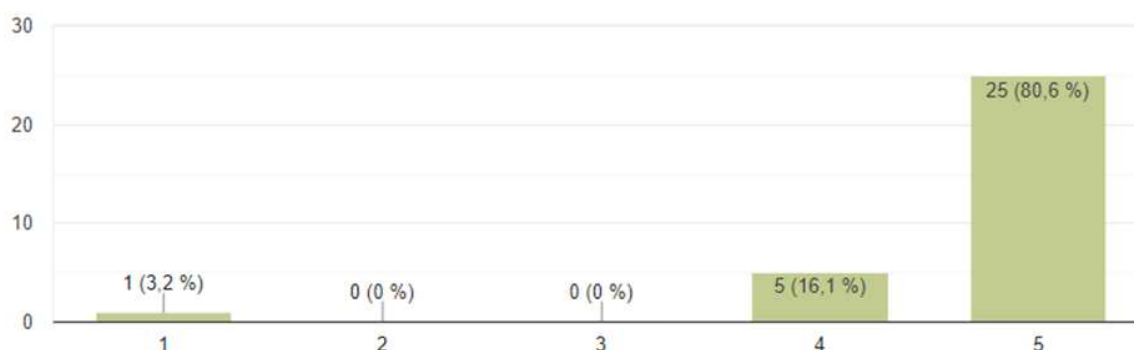


From 31 answers 87,1% of the responders find the structure of Concepts extremely well-structured, 9,7 % as well structured and 3,2% normal structured.

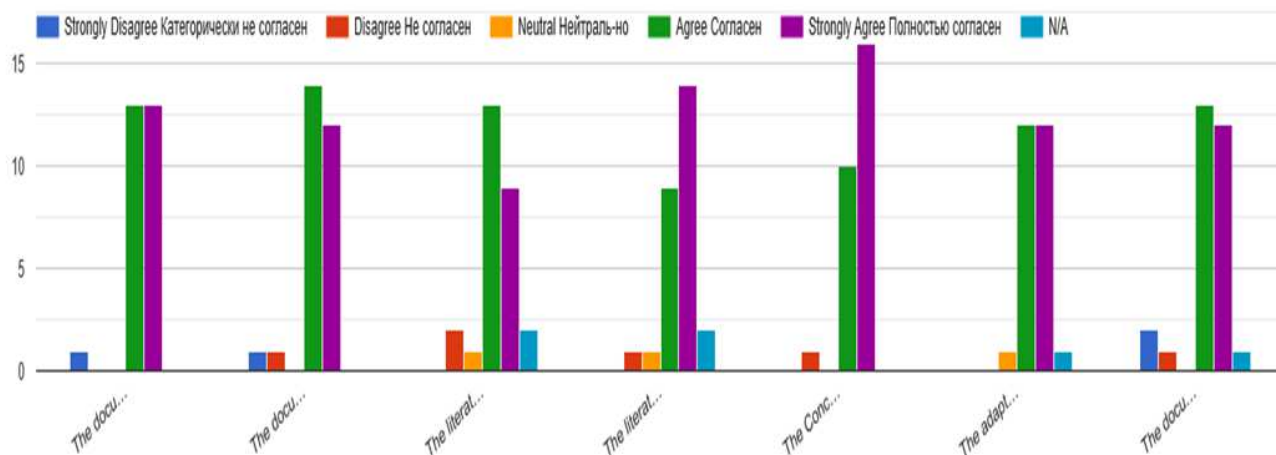

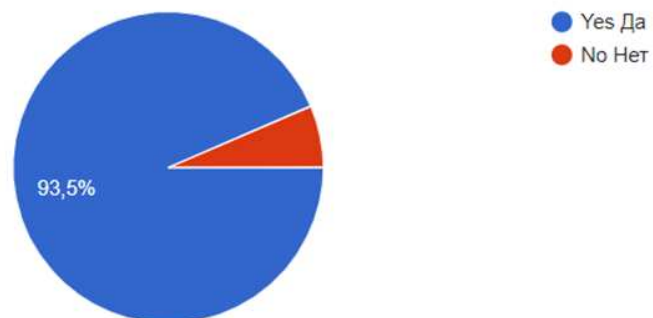

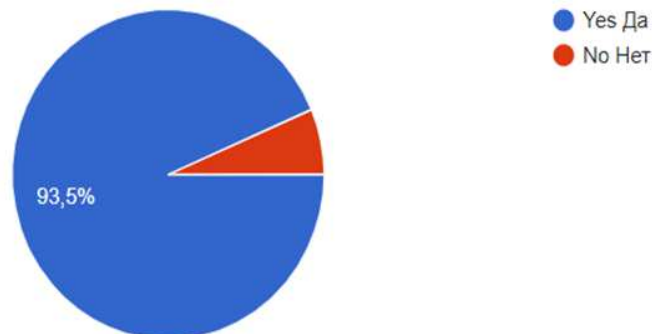

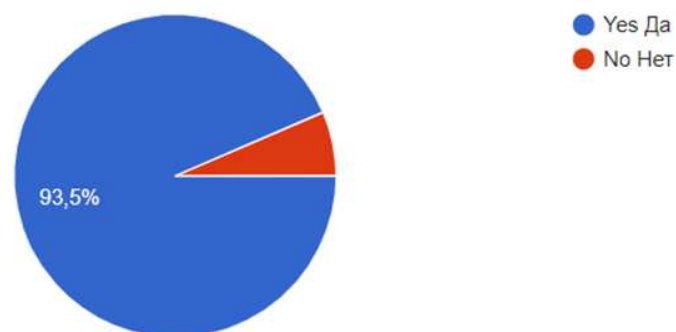

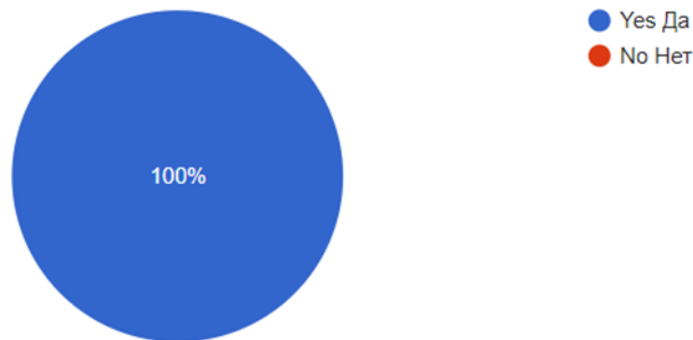

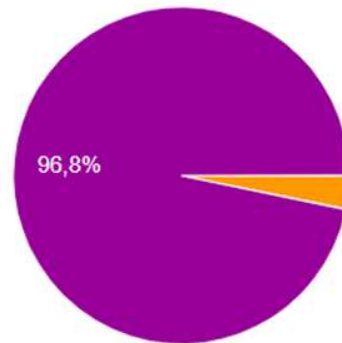
