The purpose of the evaluation was to collect feedback on the Cloud-based Virtual Library of the digital educational resources. The Cloud-based Virtual Library of the digital educational resources was developed in accordance with the project "Modernization of the system of higher education in Central Asia through new technologies" (HiEdTec). The Cloud-based Virtual Library of the digital educational resources aims to create the availability of educational courses in open access to all teachers, as well as students, thereby providing the opportunity for EVERYONE to study at ANY time and in ANY place with the help of ANY teacher, using ANY device.

Project overview

The main aim of the project is to adapt the education system in the partner countries in Central Asia (PCs or partner countries) to the digital generation through introduction and effective use of ICT-based Innovative Educational Technologies and Didactic Models (IET&DMs) in the teaching process.

technologies and online delivery to improve pedagogies and assessment methods. The project will help turn the partner's higher educational institutions (HEIs) into innovative Universities and will improve the quality of the trained specialists who are necessary to perform the Digital Transformation of Industries (Industry 4.0). The consortium comprises of 24 full partners – HEIs from 4 EU countries and 5 partner countries in Central Asia. The consortium includes two types of higher education institutions (HEIs): European HEIs with solid experience in the innovative educational technologies and HEIs from Central Asia which want to introduce these technologies and open pedagogies in the field of higher education in order to improve and extend the supply of high quality learning opportunities tailored to the needs of digital learners.

In the framework of project realization it was created 5 virtual libraries in each partner country. A virtual library of Tajikistan has been created with digital educational resources based on the distance learning environment Moodle LMS. Address of library: <https://moodle.tut.tj/> .

Through the HiEdTec project, communication equipment was supplied to the universities of the consortium of the Republic of Tajikistan, on the basis of which a virtual library of Tajikistan was created. The main server is located in TUT. The virtual library of Tajikistan was created by the TUT team.

The virtual library is made in accordance with the requirements of the project, there are mandatory elements - the logo of the European Union, the logo of the HiEdTec project and information about the project.

Also on the main page of our virtual library there are 3 categories of courses. These are courses of the following universities: Khorog state University named M.Nazarshoev, Tajik technical University named M.Osimi and Technological University of Tajikistan. All courses are developed using elements and resources of the Moodle platform.

1. *Which country are you from?* 176 responses from Tajikistan

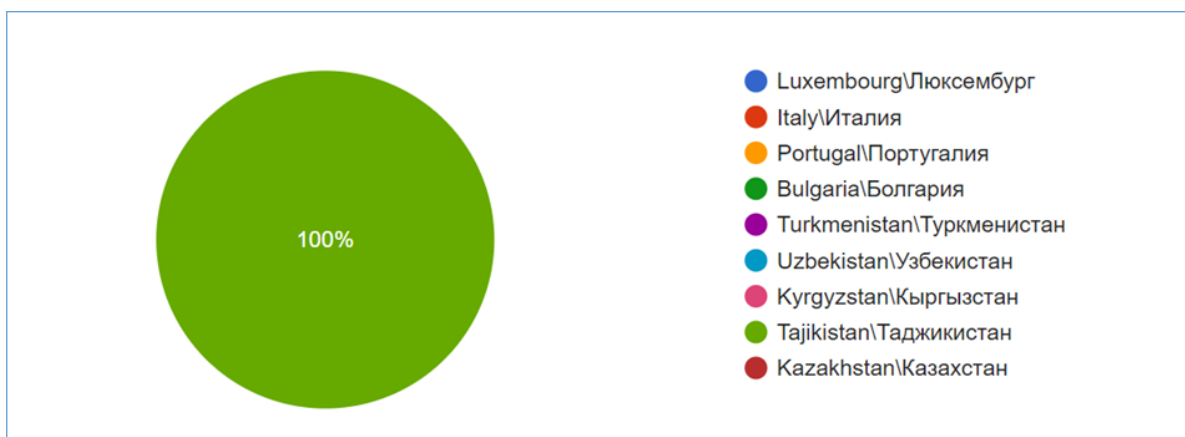

2. *Who are you?* 172 responses answered to this question. As it shown on fig.2 - 67,4% are students and 31,4% are teachers.

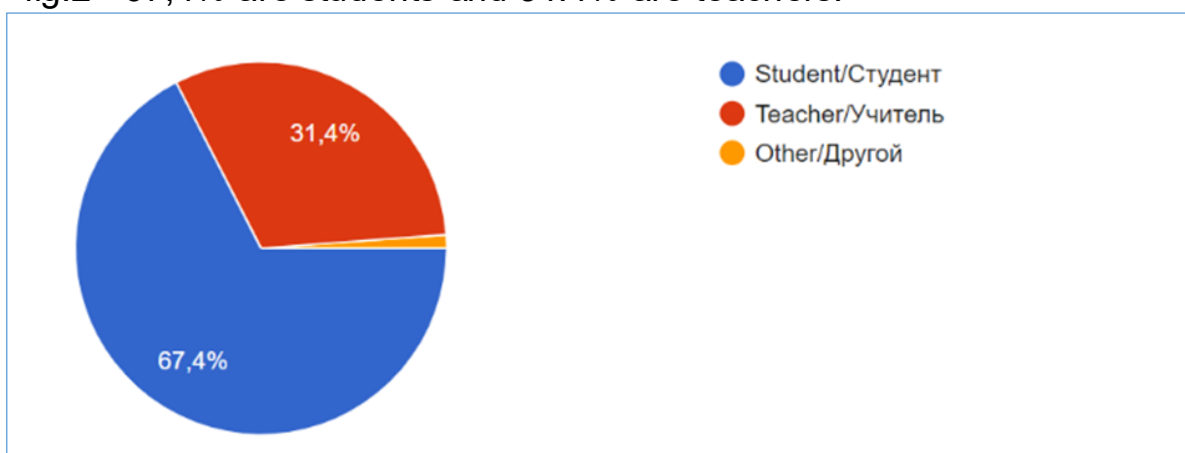

From 176 answers 96,6% of the responders find the structure of training courses extremely well-structured, 2,8% as well structured, and 0.6 % - not at all well-structured.

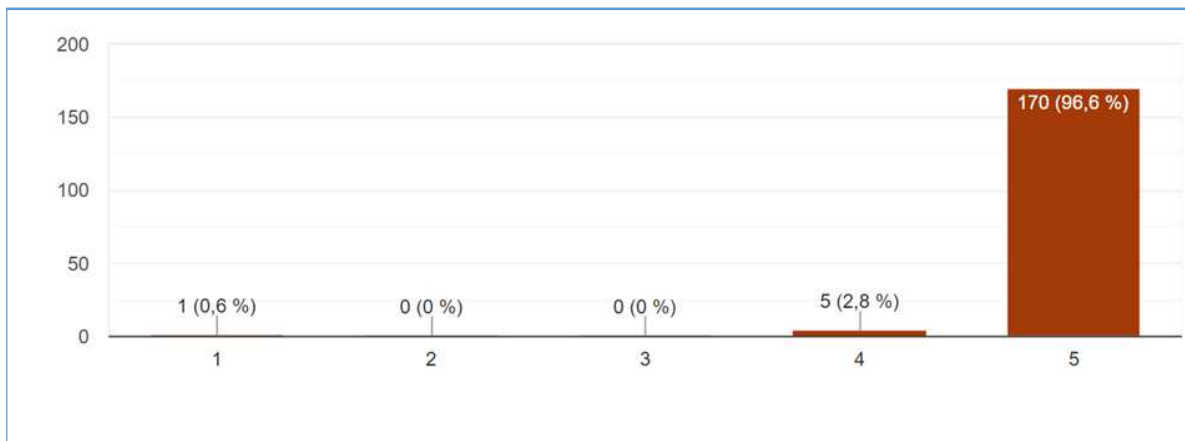

There were 176 answers for this question, from which 94,3% find the quality of the training course extremely good, 5,1% as very good, and 0,6 % - very bad.

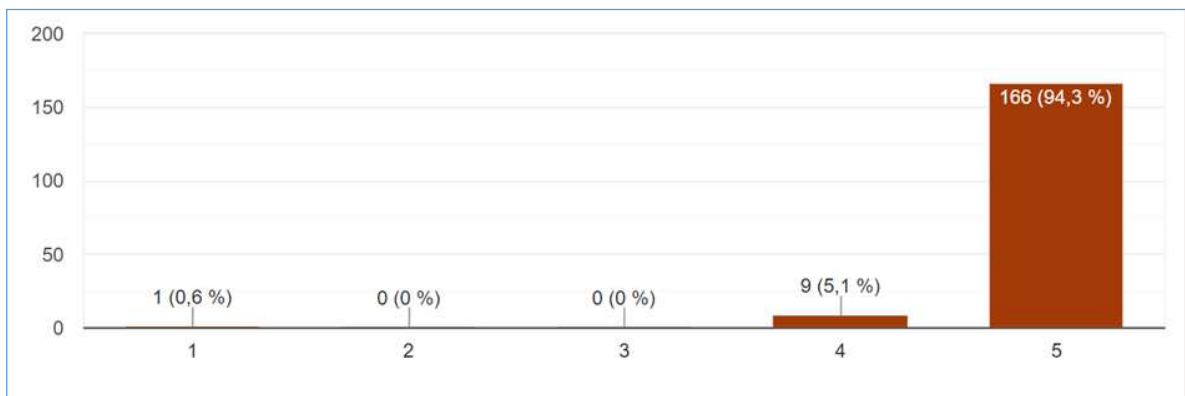

There were 175 answers for this question, from which 95.4% find the the search function of the library extremely good, 4% as very good, and 0,6 % - good.

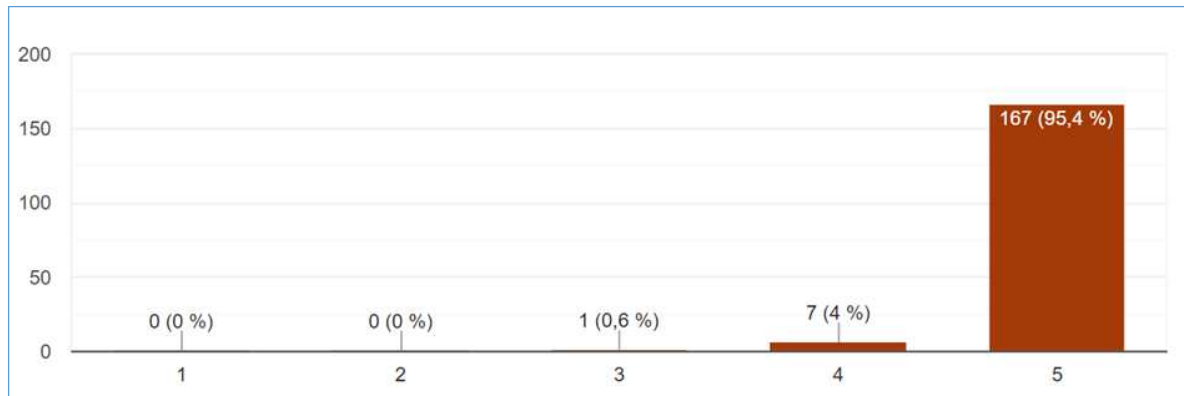

There were 172 answers for this question, from which 45,9% find the the search by title, 44,2% by author, and 9,9% - by subject.

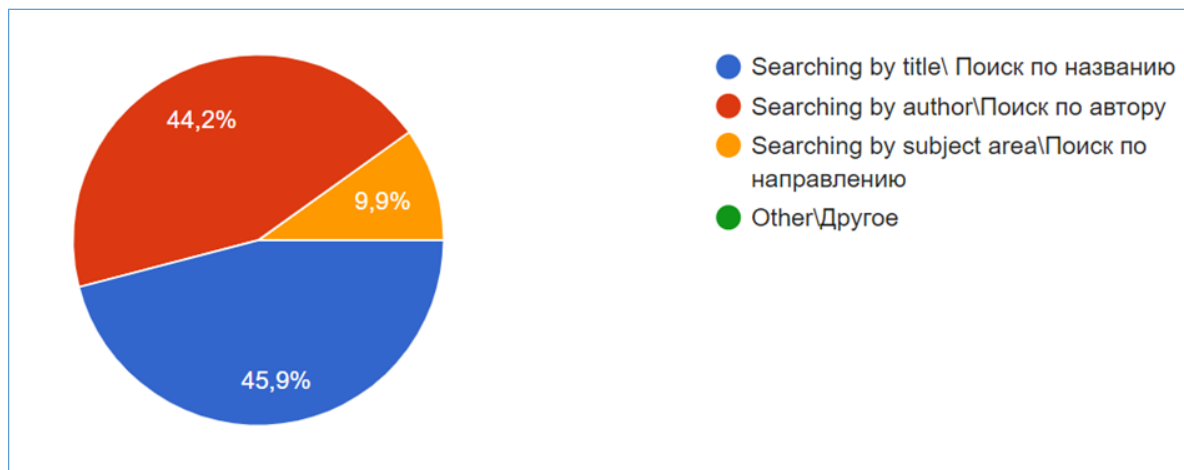

There were 175 answers for this question, from which 78.3% responded as excellent, 17.1% - good, and 4,6 % - as good.

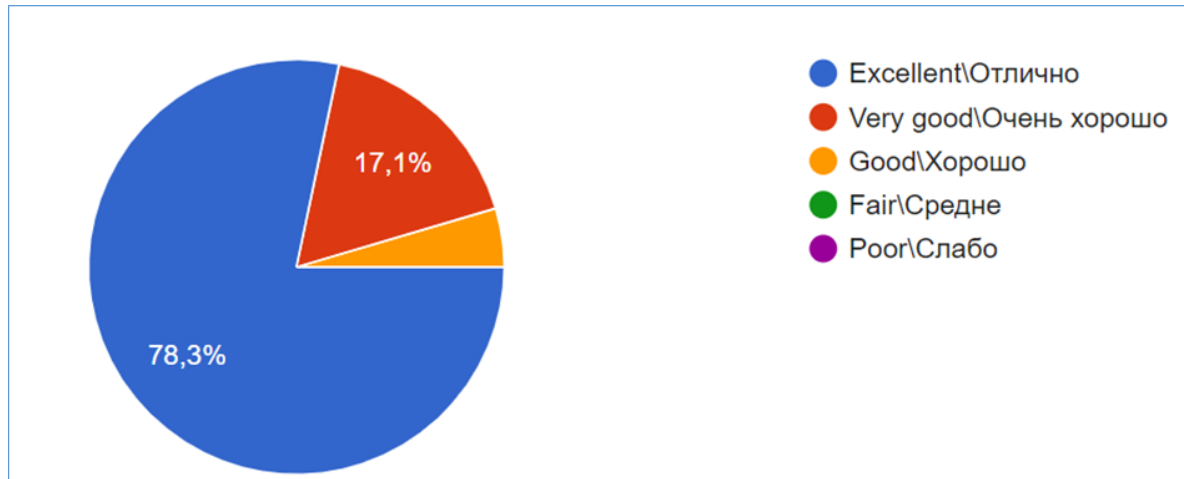

From 175 responses 99,4% answered "YES"

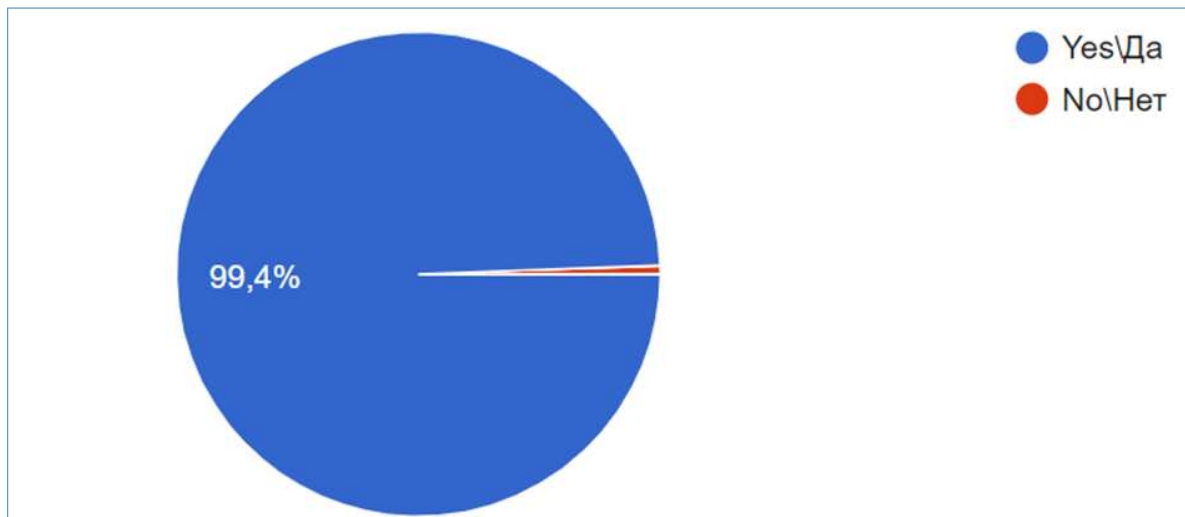

From 176 responses, 99.4 % answered "YES"

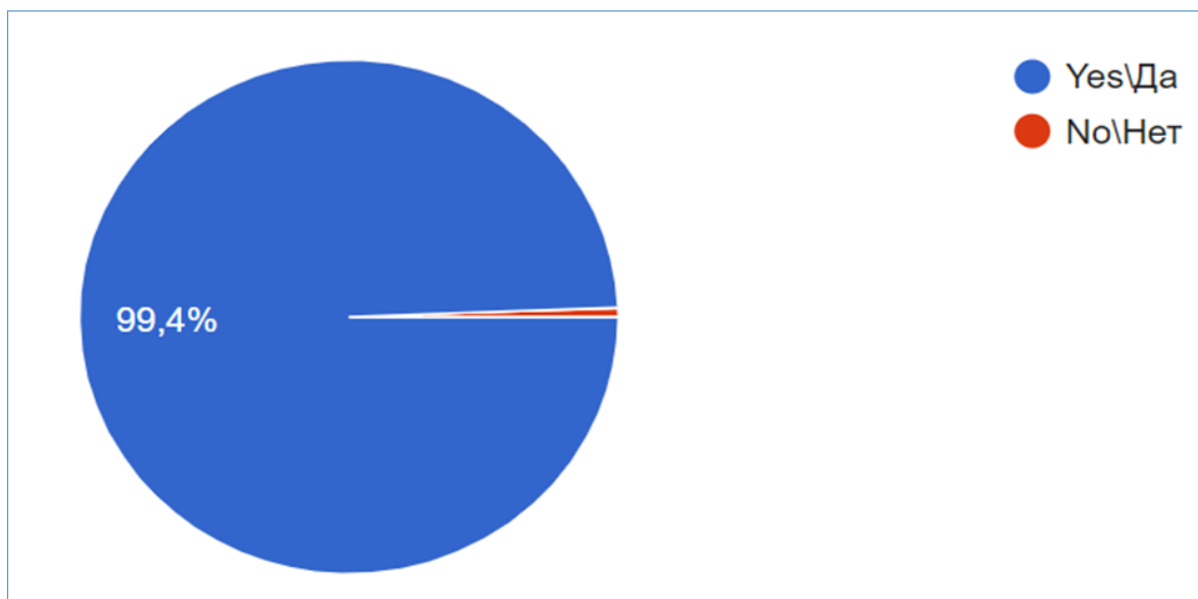
