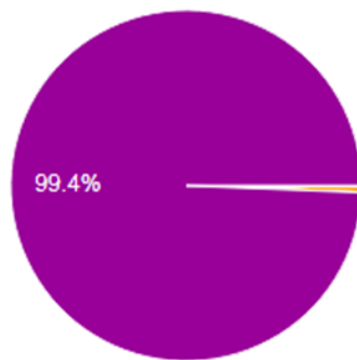

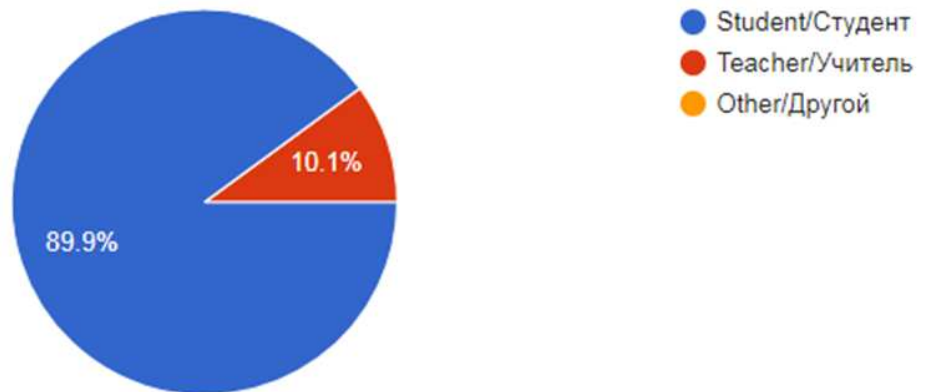

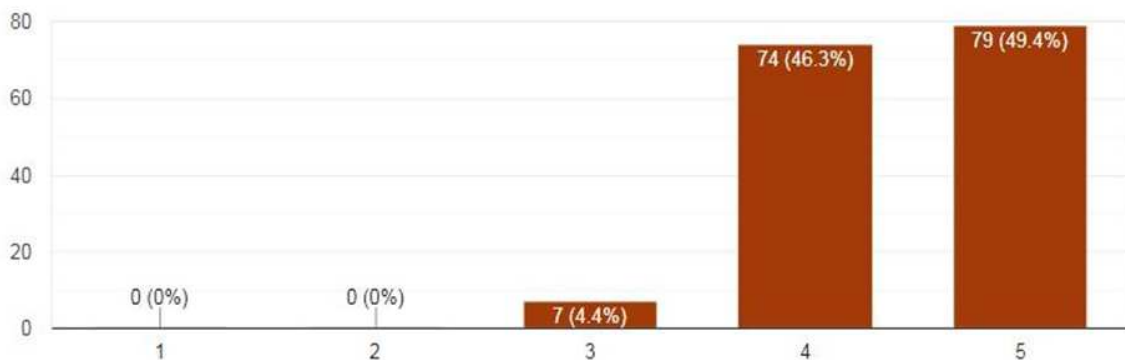

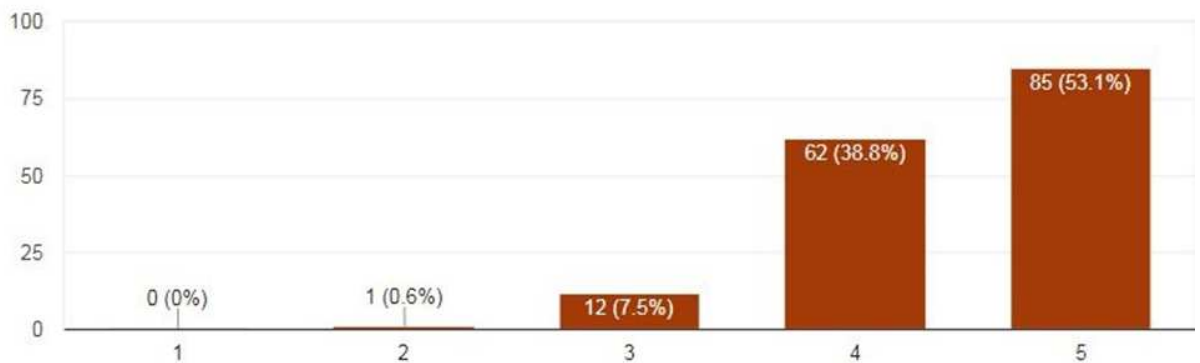

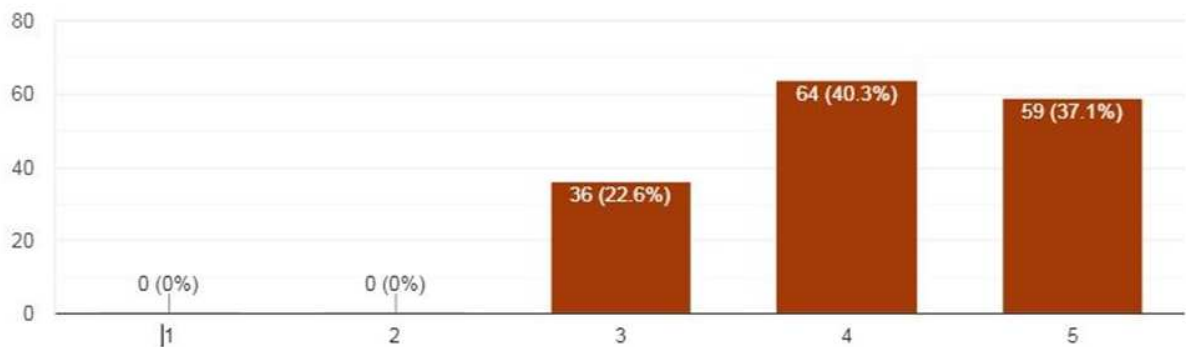

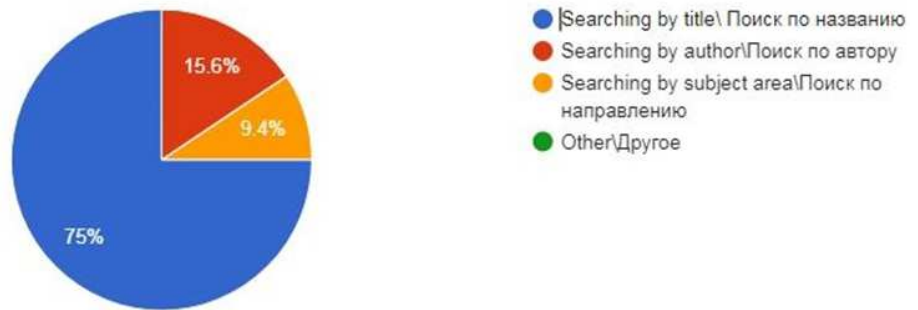

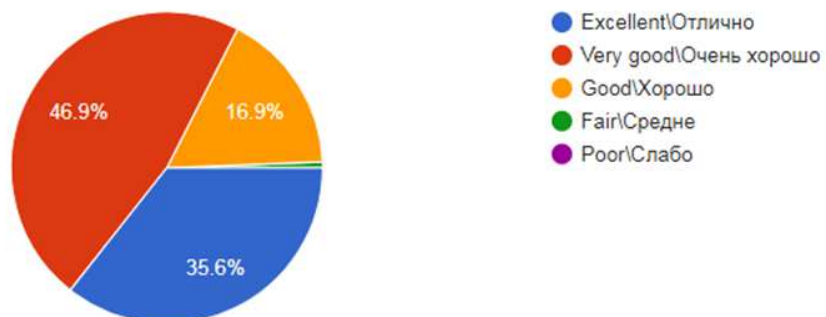


**7. How would you rate the search functions mentioned in question 6? 160 responses**

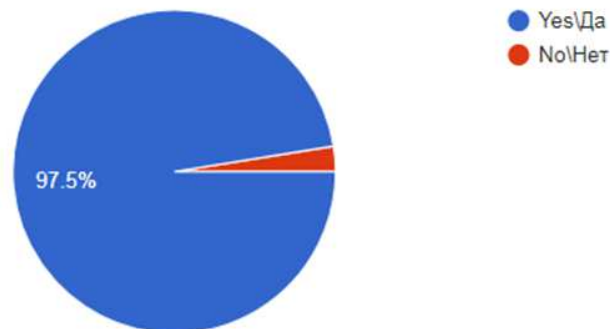


## 12. Was the installation of the cloud-based Virtual Library of the digital educational resources done on time? 159 responses

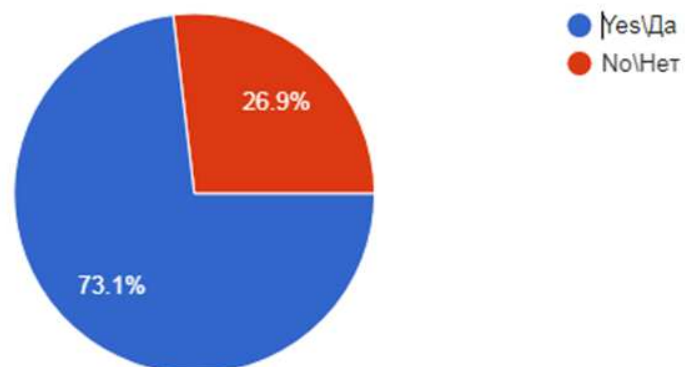
